In accordance with Article 13 of Regulation (EU) No. 679/2016 (hereinafter referred to as "GDPR"), TA.BU. S.S.D. a r.l., informs you of the following:

## \*\*A) Data Controller\*\*

The Data Controller is TA.BU. S.S.D. a r.l., located in Lignano Sabbiadoro (UD) — 33054, via Brescia 18/B, Tax Code 02886410303 - VAT No. 02886410303 (hereinafter referred to as the "Company"). The Controller can be contacted at the certified email address postmaster@pec.polisportivatabu.it, or at the regular email address info@tabusport.it.

\*\*B) Purpose and Method of Data Processing\*\*

Personal data collected through the registration form, as well as any further documentation provided to the Company, are processed for the following purposes:

1. Fulfillment of activities offered by the Company, such as sports consultancy services, attendance of individual and/or collective sports training courses, and proper management of the aforementioned activities.

Please note that the processing may involve "Sensitive" data, as it is suitable to reveal health status.

Your data will also be processed to:

- 2. Fulfill obligations required by tax and accounting laws.
- 3. Comply with legal obligations incumbent upon the Company as required by current legislation.
- 3. Illustrate or document the Company's activities for promotional purposes through data consisting of photographs and/or short film recordings.

Personal data may be processed via paper, computer, and electronic archives (including portable devices) in ways strictly necessary to achieve the above purposes. The processing is carried out by the Data Controller and, if necessary, by personnel expressly authorized by the Data Controller.

\*\*C) Legal Basis of Processing\*\*

The Company lawfully processes your personal data when:

- Processing is necessary for the performance of a contract to which you are a party or for the implementation of pre-contractual measures taken upon your request.
- Processing is necessary to comply with a legal obligation to which the Company is subject.

\*\*D) Consequences of Failure to Provide Personal Data\*\*

With regard to personal data related to the performance of a contract to which you are a party, or related to the fulfillment of a regulatory obligation, failure to provide personal data prevents the establishment of the contractual relationship itself.

\*\*E) Data Retention\*\*

Your personal data, processed for the purposes mentioned above, will be retained for the duration of the contract and, thereafter, for the time during which the Company is subject to retention obligations for tax or other purposes provided by law or regulation.

\*\*F) Data Communication\*\*

Your personal data may be communicated to:

\*\*H) Rights of the Data Subject\*\*

Among the rights granted to you by the GDPR are the rights to:

- Request access to your personal data and information regarding them, rectification of inaccurate data or completion of incomplete data, deletion of personal data concerning you (upon the occurrence of one of the conditions indicated in Article 17, paragraph 1, of the GDPR and in compliance with the exceptions provided in paragraph 3 of the same article), and restriction of processing
- of your personal data (under the circumstances indicated in Article 18, paragraph 1, of the GDPR).

   Request and obtain from the Company, in cases where the legal basis for processing is the contract or consent, and processing is carried out by automated means, your personal data in a structured and machine-readable format, also for the purpose of communicating such data to another data controller (so-called "right to data portability").
- Object at any time to the processing of your personal data in specific situations concerning you.
- Withdraw consent at any time, limited to cases where processing is based on your consent for one or more specific purposes, and concerns common personal data or special categories of data, such as those revealing health status. Processing based on consent prior to its withdrawal remains lawful.

Lockers found closed at the end of the day will be forcibly opened to allow use by other members
